

**ADDENDUM**  
**INCENTIVE GUIDELINES**

Effective January 3, 2022

**SCOPE :**

New Dealers may opt to receive their weekly incentives via bank transfer.

**REGISTRATION GUIDELINES:**

1. Applicable to New Dealer Accounts registered from January 3, 2022, onwards.
2. Not available for minors.
3. If currently a Dealer already, a new Dealer No. must be enrolled in this program and must be indicated on the Incentive Auto-Credit Form. This Dealer No. must not be registered yet with the PowerWallet/PayMaya platform.
4. Dealers must fill up an INCENTIVE AUTO-CREDIT FORM.
5. Dealers must submit the Incentive Auto-Credit Form, together with the following documents:
  - a. Dealer Information Sheet;
  - b. Proof Of Bank Account, and
  - c. Copy of a Primary ID (see FVP list of acceptable Primary IDs.
  - d. Affidavit of Identity for crediting of multiple accounts (not enrolled in the PowerWallet system).

**APPLICATION GUIDELINES:**

**INCENTIVES:**

1. Incentives will be released via bank transfer on a weekly basis.
2. Incentives will be deposited into the bank account nominated by the new dealer in the Incentive Auto-Credit Form.
3. Auto crediting of incentives earned will start on February 11, 2022 (1<sup>st</sup> cut-off of February = Feb 1-7, 2022)
4. Incentive Auto Credit Form may be submitted as early as January 10, 2022.

**SOCs:** (local)

1. SOC's earned will still be in product form
2. Every twelve (12) SOC's earned will be delivered FREE to the dealer
3. This may be claimed/redeemed through the MyAssistant Online Program. (Must have a MyAssistant Account.)

**SCQs:** (local)

1. SCQs earned will still be in product form.
2. Every twelve (12) SCQs earned will be delivered FREE to the Dealer.
3. This may be claimed/redeemed through the MyAssistant Online Program. (Must have a MyAssistant Account.)

SOCs: (international)

1. SOC earned will no longer be in voucher format.
2. SOC earned shall be included, with monetary value, in the computation of the dealer's net incentives.
3. SOC earned shall be released in the form of cash, together with the net incentives earned.

SCQs: (international)

1. SCQs earned will still be in product form.
2. Every eighteen (18) SCQs earned will automatically be converted into a TITANIUM POWER PACK, and delivered FREE to the Dealer.
3. This may be claimed/redeemed through the MyAssistant Online Program. (Must have a MyAssistant Account.)

**CLAIMING GUIDELINES FOR SOC & SCQ:**

There are two (2) options for claiming SOC and SCQ products:

1. Through the MyAssistant Online Portal (Must have a MyAssistant Account.)
  - 1.1. For every twelve (12) SOC or SCQs earned, the Dealer will be able to claim these twelve (12) boxes through the portal. Delivery is free.
  - 1.2. For claiming eleven (11) or less SOC or SCQs through this portal, corresponding shipping and handling fees shall apply.
  - 1.3. Required number of SCQs or SOC to qualify for free delivery is either twelve (12) SCQs or twelve (12) SOC. Combination of twelve (12) SCQs and SOC does not qualify for free delivery.
2. Through personal claiming at the FVP Head Office

NOTE: Deliveries outside of NCR shall be subject to the courier's policies on serviceable areas.
